PAYMENT TERMS AND CONDITIONS:

1. Payments can be made in Cash/Cheque/Demand Draft favouring 'Venkateshwara Education Society' payable at Hyderabad. Online transfer facility is available.
2. Other items like Uniform, Shoes, Socks, Identity Card, Books, Stationery and such other items have to be procured from school at additional cost.
3. The fees paid under category A, B, D, E, F, G once paid will not be refunded or adjusted under any circumstances.
4. Last date for payment of fees: I Term -15th April, II Term -15th August, III Term-15th December of the academic year. After the due date fine of Rs 100/- per day will be charged.
5. If there is a withdrawal of a student from school in the middle of the term, the tuition fee for the entire year has to be paid to procure T.C [Transfer Certificate]. In general, minimum yearly increase of 10 per cent in the fee may be expected. The above fee is excluding taxes. In case any tax is levied by the government, parent will be informed regarding subsequent increase in fee.
